Bernardo Calzadilla-Sarmiento, Director, Department of Digitalisation, Technology and Innovation, UNIDO; Alison Gillwald, Executive Director, Research ICT Africa; Marilia Maciel, Digital Policy Senior Researcher, Diplo Foundation and Lorrayne Porciuncula, Executive Director, Datasphere Initiative were panellists in the session moderated by Rashid S Kaukab, Executive Director, CUTS International, Geneva.

The panellists raised concerns about data localisation on trade, economy and sustainable development as it might

negatively impact competitiveness, innovation and e-trade. Data localisation mandates might make it difficult for smaller firms to operate cross-border as it will increase the cost of data storage, compliance burden and differentiation of personal and non-personal data.

<u>CUTS Comments on</u> Rajasthan Virtual Online Sports (Regulation) Bill, 2022

The Department of Finance, Government of Rajasthan, invited comments on the Draft Rajasthan Virtual Online Sports (Regulation) Bill, 2022. The bill aims to regulate virtual online sports and includes esports competitions, fantasy sports, derivative formats that courts approve, self-

regulatory organisations or any other appropriate authority. CUTS International recommended the government to make the bill more robust by stating what constitutes games of skill and games of chance and include regulation of all kinds of skill-based pay-to-play online games within the bill's ambit. The Rajasthan Virtual Online Sports Commission should be empowered with more powers, such as licencing. The Government of Rajasthan must ensure that the bill is in

synergy with other upcoming Central and State legislation.

National Data Governance Framework Policy 2022

The MeitY released the draft National Data Governance Framework Policy 2022 (NDGFP). India has deliberated governing frameworks around non-personal data to drive economic growth by preventing market distortions and promoting entrepreneurship and innovation.

CUTS International welcomes this important and progressive step towards foresight unforeseen implications through consultation and deliberation with stakeholders on NDGFP. It recommends the policy should clearly outline how India Data Management Office (IDMO) will achieve its intended goals and state the principles which should be followed by the IDMO while performing its duties.

Online Gaming Regulations

CUTS International submitted its comments to the MeitY on online gaming regulations. It has recommended a tiered mechanism for grievance redressal of consumers, which should be mandated through statutory provisions in regulations. In the first step, grievances should be solved by the online gaming platform. If it fails, consumers should have the right to appeal to the Self-Regulatory Organisations, which should have an ombudsperson to address grievances.

Registered Medical Practitioner (Professional Conduct) Regulations, 2022

The National Medical Commission invited comments on Registered Medical Practitioner (Professional Conduct) Regulations 2022. CUTS International focused on a few important issues in the regulations. Registered Medical Practitioners (RMP) registered under the National Medical Commission (NMC) Act 2019 should use the prefix of Med. Dr. before their name while displaying a unique registration ID in their prescription and money slips. RMPs who wish to practice in another state (due to transfer of work or residence) should

Future of Non-Personal Data Governance in India

The Non-Personal Data (NPD) governance framework aims to unlock the value of data in a way that leads to the fulfilment of 'public interest purposes' through establishing a community rights framework. Apart from the NPD governance framework, sectoral-level initiatives include the Data Empowerment and Protection Architecture and National Health Data Management Policy. These have also prescribed conditions of consent and data management mechanisms that would inadvertently affect consumers.

This Policy Brief highlights key issues in the data governance ecosystem from the lens of the NPD Governance Framework proposed by Committee of Experts.

Impact of Regulatory Uncertainty on Ease of Doing Digital Business in India

Regulating the digital economy becomes tougher due to its cross-cutting nature, which causes regulatory overlaps. Further, the difficulty intensifies due to the lack of regulatory procedures.

The Discussion Paper highlights several reasons that cause regulatory uncertainty for digital businesses, including lack of regulatory framework, excessive delay in enacting regulations, the arbitrary approach of regulators, suboptimal or ambiguous design, incorrect interpretation and failure in effective and efficient implementation. The paper analyses how regulatory uncertainty caused due to these factors affects the digital business from different sectors such as ecommerce, online gaming, ed-tech and fintech.

Impact of Inadequate Digital Infrastructure on Ease of Doing Digital Business in India

The Discussion Paper unpacks the digital infrastructural constraints that hinder the digital economy's growth and the digital business ecosystem. In its analysis, the paper goes beyond 'connecting the unconnected' framework, in the spirit that connectivity does not necessarily translate into positionality to use services and business opportunities offered by digital technologies.

Further, the paper breaks the entire gamut of digital infrastructure into two parts – soft and hard digital infrastructures. Throughout this paper, an attempt is made to ascertain the role of digital infrastructure and related challenges in Ease of Doing Digital Business in India that can inform policymakers, business leaders and investors.

Impact of Unnecessary Compliances on Ease of Doing Digital Business in India

The Discussion Paper distinguishes between necessary and unnecessary compliances by using elements of the regulatory guillotine framework and expands upon the core principles of 'legality', 'necessity', and 'business friendliness'.

Further, the paper renews the discussion on unnecessary compliances, costs associated, and their impact on digital businesses. It concludes with recommendations for simplifying, amending and repealing unnecessary compliances and installing good regulatory practices.

ccording to the World Health Organisation, India is home to nine of the ten most polluted cities worldwide. A significant contributor to air pollution is the transport sector, in which road



transport is the main sub-sector accounting for over 95 percent of the total transport sector's emissions.

In this regard, CUTS International has undertaken a study, 'Accelerating Electric Vehicle Adoption in Rajasthan,' to identify current supply and demand side gaps and various policy practices. These could be undertaken by the state-level authorities to ease the transition to electric vehicles in Rajasthan. Under this project, a

series of digital stories in five cities of Rajasthan: Jodhpur, Udaipur, Kota, Jaipur and Alwar were released.
