### Future of Work in India

### Why and how labour and technology can gainfully coexist

CUTS International organised a webinar on "Future of Work in India: Why and how labour and technology can gainfully coexist" on May 01, 2023. This webinar was conducted on Labour Day to understand how the future of work will be in relation to advancement in technology.

Experts from different backgrounds who have knowledge related to present working conditions and transitions due to upcoming technology with the influence of AI and automation of work participated as panellists in the webinar and provided their insights on the topic.

The key issue of this webinar was related to the improvement of the productivity of the labour force which would be able to compete on a global scale. In India, manufacturing and Micro, Small and Medium-sized Enterprises (MSMEs) are the largest contributors to job creation. The Government of India and state governments must focus on these sectors for creating good and better jobs.

According to experts, there is a need for creating a system for direct benefit transfers which provides support to people in the period of transition by providing them with social welfare support and skills to work together.

The experts also emphasised on developing and executing the policy at the district level and then aggregating them. There is an urgent need to incorporate



circular thinking and transparency in public policies.

### Agrivoltaics in India Challenges and Opportunities for Scale-up

CUTS International in consortium with International Institute for Sustainable Development (IISD), The Energy & Resources Institute (TERI), and GIZ India released a guidebook for state policymakers on implementing decentralised solar power plants through PM-KUSUM components A and C (feeder-level solarisation) and a background paper on Agrivoltaics in India.

This guidebook provides recommendations to state policymakers on how they can implement solar irrigation models effectively and sustainably by setting up small-scale solar power plants at the substation level to power rural feeders. Solarising agricultural feeders can improve the quality, timing, duration, and predictability



of power supply for farmers. It can also reduce power purchase costs for states and distribution companies, help create green jobs, and improve power grid stability in the long term.

Wi-Fi has emerged as the preferred mode of connectivity, even in Tier-III and rural areas. However, there is room for improvement in Wi-Fi services' quality of experience through competition, standards, and consumer grievance resolution. To seize the future of Wi-Fi, a supportive ecosystem involving compatible devices and early adoption are vital. Enhancing awareness and security for public Wi-Fi and for the PM-Wani scheme is also important.



CUTS findings from the nationwide in-depth interaction-based study from the project 'Understanding Consumer Perspectives on the 6 GHz Band' aimed to comprehend consumer perspectives, challenges and concerns regarding the current state of internet connectivity as well as their expectations for future technologies.
