

Session I: Meeting of the BRICS Working Group for Research on the Competition Issues in the Automobile Markets (Industry 4.0)

This session will brainstorm the prospects of the BRICS Working Group for Research on the Competition Issues in the Automobile Markets. The Working Group has been a successful cooperation format for the BRICS competition authorities and results of its work include a research report on competition issues in the automotive sector released in 2021. The report highlighted the emerging issues in the automobile industry and called upon competition authorities to keep an eye on the effects from digitalization of the sector.

This session proposes to upgrade and widen the Working Group mandate drawing the Group's attention to disruptive changes brought to automobile and other heavy industries by digitalization and data-driven technology (Industry 4.0). Participants are welcome to map the problem field of competition law in Industry 4.0 including issues of industrial data ownership and access to essential infrastructure. The session will discuss ways for competition agencies to keep pace with digitalization processes in their national industries and foster the development of national Industry 4.0 players that can effectively compete with incumbent global providers of technology and industry-relevant data.

17:00-18:15 Session II: Ecological Approach to Competition Law in the New Economy

This session will focus on the innovative approach to the ecosystem economy that views digital ecosystems as similar in many ways to their natural counterparts. An ecological approach to regulation of digital ecosystems and platforms – ecoantitrust – presumes that ecosystem businesses are organised as complex systems and thus their features and behavior can be compared to some pivotal examples of complex systems – natural ecosystems. This approach uses analogies and methods from ecology and biology to formulate a new toolbox for regulators tasked with controlling the growing power of digital ecosystem businesses. This session will include a presentation of the Ecoantitrust project followed by a discussion.

18:30-19:55 Session III: Ex Ante Rules and Competition Law for the Digital Economy. Indian Perspective

Faced with the challenges of the digital economy, regulators around the world are struggling to choose the right mode of action. While equipping existing competition law with new tools calibrated for digital markets may be one option, an increasing number of jurisdictions prefer to draft rules that target certain digital platforms and a specific list of harmful practices. For competition authorities, this may mean that competition law is losing its regulatory relevance in the new economy.

To put a spotlight on these issues, this session will discuss the Indian approach to the digital economy that strives to combine ex ante rules with the competition law

machinery. The session speakers are invited to share their views on the future of the Indian digital market and the recent regulatory initiatives such as the Competition (Amendment) Bill, particularly implementation of deal value threshold, calculation of global turnover for a penalty, intellectual property rights as an exemption etc., as well as the proposed institutional changes to the CCI. The goal of the session is to envision India's place among the pioneering jurisdictions that strive to develop a sustainable digital economy including by reinvigorating the power of competition law.
