





Report on Civil Society Coalition for Reforms in Electricity Distribution

6th February, 2020, Jaipur, Rajasthan

INTRODUCTION

CUTS International and Bask Research Foundation are working to improve consumer participation in electricity related regulatory affairs in Rajasthan, safeguarding consumer rights and advocating for better standards of performance for electricity utilities.

In line with the above stated objective, a one-day workshop was organized in Jaipur focusing on power sector issues and inefficiencies which impact electricity consumers, and potential role of civil society in improving accountability and efficiency in the sector (electricity distribution). Some key tools were released for capturing evidence / date related to commonly prevalent issues on the ground related to electricity services.

The key objective of the workshop was to form a coalition of civil society organizations for collective advocacy and mobilize grass-root resources for capturing evidence for issues so that they may be raised through appropriate platforms¹.

KEY DISCUSSIONS

I. Issues in Power Sector impacting Electricity Consumers

The session discussed issues across 3 key categorical divisions: Policy Design, Regulatory Compliance and Execution and Electricity related Consumer Services. The session covered challenges of accountability, inclusivity and transparency in policy design. This was followed by discussion of inefficiency and performance of distribution companies, while highlighting apathy towards consumers. Challenges such as passing on costs of DISCOM non-performance to consumers, increasing accidents, poor state of grid infrastructure (especially in rural), poor integration of IT services and blatant non-compliance of RERC regulations and orders were discussed. Lastly, the state of services rendered to electricity consumers, especially in rural areas, was discussed. This included issues like grievance redressal, VCR filing, power quality, safety, metering and billing.

II. Role of Civil Society for ensuring accountability and delivering reforms in Power Sector

The objective of the session was to highlight the potential of impact through collective civil society action in power sector and the need for same. While the session discussed various channels for engaging key actors in power sector, resources and capacity required for same, it also outlined a strategy for coordinated efforts and sharing resources for taking collective action across the power distribution value chain at the least.

III. Panel Discussion: Learning from the Consumer Activists

This panel discussion focused on learning from Consumer Rights activists active in the power sector. A brief about panelists and the discussion is as below:

- Mr. Liaqat Ali, an activist based in Jodhpur discussed his experience of working in regulatory reforms through participation and filing petitions with RERC.
- Mr. Manish Mehta, a CA by profession, shared his journey from a common electricity consumer to an informed electricity consumer. He has filed 125 cases against JVVN in last 12 years. Cases have largely been litigated in CGRF and Ombudsman level.
- Mr. Hari Prasad Yogi, a consumer advocate from Sawai Madhipur shared his
 experience of fighting for consumer rights, and discussed legal options available to
 consumers.
- Mr. Rakesh Parmar, an active selfless consumer advocate from Dholpur, informed the
 participants about potential of RTI and how to use it as an effective tool to ensure
 accountability. He also discussed best practices to take up grievances with CGRF and
 Ombudsman.

IV. Tool for capturing Evidence

The last session of the workshop launched app based tools for capturing evidence related to following issues:

- Inaccurate metering or billing
- Electricity related accidents
- Faulty or poor electric infrastructure
- Incorrect filing of VCR
- Reporting poor quality of supply (curtailment, voltage fluctuations)

The session offered a hand on training to the participants.






